A Special Summer Home.....

A walk or a drive around Lake Parker brings you close to Glenn and Nancy Barber's blue cottage at the water's edge at 441 West Shore Road. This cottage has such wonderful history we want to share it with you.

The original structure of the cottage was part of the old sawmill in W Glover, formerly located on Roaring Brook, just across the road from the current W Glover ambulance building.

That's Clyde Barber, Glenn's Dad, on the peak of the building as it was being moved in 1917 by teams of horses to its current location. With its placement, the building became the first camp on West Shore and one of the first seven summer homes on the Lake. Clyde added the lakeside porch and upstairs dormer in 1920. Clyde Barber was raised in the house just below the Lake Parker Country Store while Glenn's mother, Floy Webster lived in the residence at the W Glover store owned and operated by her par-



ents. In 1927, after their marriage, Clyde & Floy Barber moved to St. Johnsbury.

As written in his mother's diary, Glenn's first visit to Lake Parker was July 4, 1931 at the age of eight months. Glenn spent summers at the Lake for the next twenty years, with his mother, brother, Dale and


LPA Seeks Nominations for President

The West Glover pump stations and force main have been constructed and are in full operation. Due to remaining grant funds from the project, the Town intends to construct and extend the force main down Parker Rd. to serve and connect as many existing properties to the system as possible this summer. overall conceptual plan for the rest of the Lake is available.

The ultimate long-term goal of the community is to better protect the water quality of Lake Parker. Due to the small camp lots, high groundwater levels and poor soils, the majority of the on-site systems function marginally at best.

Due to the on-site septic system rule changes, several residents constructed replacement systems to avoid future permitting. However, even in doing so the groundwater table, poor soils and small lots are still problematic. The ultimate resolution to alleviate further deterioration of the water quality of Lake Parker is to install a collection system to serve the camps and houses located around the lake.

The low-pressure sewer system consists of individual grinder pump systems with small diameter

force mains connected to a larger diameter force main. An individual pump station consisting of a grinder pump in a high-density polyethylene (HDPE) tank would be constructed just outside each house. The pump controls would be mounted on the house and wired to each individual house. The standard force main (pressure pipe) from each grinder pump station would consist of a 1-1/4 inch diameter HDPE plastic pressure pipe. The larger force main collection system would consist of 2, 3 and 4-inch diameter pressure pipe.

The future project could be funded with a USDA-RD grant / loan similar to the Phase I project recently completed. The best possible financing at this point in time would be a 45% grant and a 55% loan. The funding would result in a potential loan of \$1,441,000 with an estimated annual debt retirement of \$76,000. The normal interest rate for FMHA/USDA-RD loans over the past 30 years has been

5.25-5.50 %. The new rate at this time is 3 ¼ % for 30 years. For the 130 additional users, the annual debt service cost is estimated to be \$585 per user if all of the new debt were to be paid by the additional users. In order to apply for funding, a bond vote is a requirement. There are several options available to the Town and sewer users to apply for the funding.
