
boat, pontoon boat)!

## **Walking Path Update**

The walking path is wet and muddy but that is normal for this time of year. Several small trees fell during the winter months and will be cleared by the end of June. There is one section where a new drainage ditch has been added between two of the fields. This has resulted in the need for an additional bridge. We are working on a plan and will get something in place soon to make it easier to cross the ditch.

Last year one side of the large bridge dropped several feet. One of the banks had given way under the bridge. This would have been a very difficult task for us to resolve. The good news came in the form of help from Bob Tetrault and his worker. He moved the bridge and rebuilt the bank. A huge THANK YOU from the Lake Parker Association!

## **Rainbow Trout Stocked in Lake Parker**

We are pleased to report that the State of Vermont Fish and Wildlife Dept. agreed to stock Lake Parker with 500-600 rainbow trout this year! We wish to thank our local State Biologist, Jud Kratzer of St. Johnsbury, for his efforts in setting this up. The fish were delivered on May 5th. The rainbow trout were approximately 8.75" long. Last year we collected donations from many of our members to be used to stock Rainbow Trout in Lake Parker in 2017. The regulations and permit process were not available in time to apply for this year. John Wooten stayed in contact with Vermont's Fish and Wildlife Department, which resulted in Lake Parker being stocked in 2017 without cost to the LPA. We plan to use the donated funds for stocking in 2018 or as soon as a permit is granted to the association. If you made a donation and are concerned because it was not used in 2017, please contact any board member. If you prefer your donation be returned, we will accommodate your request.

### **Additional Fishing & Wildlife Report**

In response to an inquiry during the LPA Annual Meeting last summer regarding inconsiderate fishing adjacent to docks and rafts while people are on or swimming next to same, the Committee contacted our local State Game Warden (Barton), Michael Scott. He indicated that since the Lake is a public resource, there are no statutes prohibiting fishing next to docks and rafts; however, common sense should prevail when people are on or adjacent to docks and rafts; he suggests politely asking the fishermen to fish elsewhere, and if that doesn't work, take down the boats registration and/or take photos and report the incident to him. ### **LPA 2016 Annual Meeting**

We had a great turnout for the 2016 Lake Parker Association Annual Meeting held on July 16, 2016. Below is a summary of the meeting. (These are not the official minutes.)

The meeting was called to order by President Ken Kasz at 10:10AM. There were 59 members and guests in attendance. Andrea read the minutes from the July 18, 2015 meeting. The minutes were approved by the membership. The Treasurer's report was presented by Joyce and approved by the membership.

Standing Committee Reports followed. **Membership:** Jim Scileppi reported that we had 81 members in 2015. Jim Scileppi thanked everyone who has joined this year. **Recreation:** Ann Lindner reported that there will be a boat social starting at 4PM. **Water Quality:** Randy Williams reported that Bob Richards went out recently to measure the clarity of the water. The depth was at 16 feet, which is much clearer than previously. **Boat and Water Safety:** Bob Morrill reminded that boats need lights after sunset. When traveling along shoreline the boats should be going 5mph when they are within 200 feet. Brenda Plastridge brought up the necessity of all boats including rowboats, kayaks, paddleboats, and paddleboards to have life jackets aboard. **Fishing and Wildlife:** John Wooten will file for a permit for the association to do private stocking of trout. \$200.00 was donated/collected for this purpose. He also gave us the name of our local warden, Mike Scott, for us to contact with questions and information on updates from the state. There was discussion about the loons nesting on Lake Parker.

**Old business:** The 2015 photo contest yielded over 65 pictures. Winners of the contest were awarded a free calendar. 68 calendars were sold for 2016, 30 more than the previous year. \$241 in profit from the sales were donated to the association.

Walking path update: Ken stated that the large bridge was repaired by Robert Tetreault or his worker. He asked that we all thank him when we see him. A gift certificate was given to him for his help. Also several other wet areas were improved with raised walkways by volunteers.

**Greeter program**: Ken attended a greeter training program. The board previously discussed a volunteer greeter program and decided not to undertake a new program at this time. New posters have been put up on the board at the fishing access urging people to check their boats before and after entering the lake.

**Telephone cascade**: Brenda Plastridge stated that the telephone cascade will be updated to include new residents.

## **LPA 2016 Annual Meeting continued**

Art Greenbaum had a sign made, for the driveway at the south end of the lake which is often used as a fishing access area, asking people to take their trash out with them. Thank you Art.

**Nominations and Officer Elections:** Ken Kasz was nominated to a third 2-year term as President. Randy Williams resigned his position as the Water Quality Chair. Art Greenbaum volunteered to fill the position and was nominated. The election was held and both Art and Ken were voted into the positions.

**New business:** Member packets: Packets have been made up for each member with information that is pertinent. New information will be added as needed. Brenda will check on the areas assigned by the state not to have weeds harvested and get that information out to everyone.

**Photo contest**: Send photos for the 2016 photo contest to Ken. The new 2017 calendars will be on sale for \$15 plus shipping.

**Website/newsletter help** - Someone with knowledge of WordPress is needed to help with the updating of the Lake Parker Association website. Ken requested stories for the newsletter. You can send them to his email address.

**Pot luck dinner**: The annual potluck dinner will take place on August 20th at 6pm. It will be held downstairs in the West Glover church basement.

**Other new business:** A suggestion was made for a reduced speed limit sign to be posted on West Shore Road. Anyone interested in seeing that happen should attend a select board meeting and bring it up. Randy brought up ambulance subscriptions. He can take care of that for anyone interested. The ambulance squad is planning to hold classes for emergency medical training in the future. They would be willing to do first aid classes also. Betsy announced that the West Glover church will be celebrating an anniversary on July 12th, 2017. Any help will be appreciated. Judy Burrell will be accepting donations for the steeple fund.

Adjournment: The meeting was adjourned at 11:35 am.
