Meeting held regarding Phragmites Weeds

A little background on Phragmites. At our annual meeting in 2018 there were a few individuals who were concerned about a weed they had on their beachfront and the spillway. After the meeting the board reached out to the State of Vermont and had someone come up to take a look. We had a representative from the State that came up and toured the Lake via pontoon boat. There was also another pontoon boat filled with LPA members. We found out that the weeds in question were phragmites which are invasive. At that time, we also found out that camps that have nuisance weeds in the water in front of their camps could fill out applications to put a mat down so they would have easier access to the water for swimming and boating; (there is a fee for the process), the applications would then be reviewed and after consideration could be approved by the State. We have had some camp owners that have gone through that process.

This year there were a larger number of camp owners that showed more concern over Phragmites. On September 27, 2019, interested members of the LPA including Board members met with Misha Cetner, Lake and Shoreline Permit Analyst and Ben Copans, Regional Watershed Basin Planner from the State of Vermont, at Brenda and Tim Plastridge's residence. The purpose of this meeting was to discuss the weeds and water quality of Lake Parker.

Below is a brief summary of the information presented by the State reps at this meeting.

- 1. Phragmites. This is an invasive plant and is difficult if not impossible to eliminate once it takes hold. Control, not elimination is possible. It is typically spread by seeds, not by boats. Misha outlined possible control methods. He noted that there is a timeline for eradicating them safely to prevent further spreading. He suggested that LPA start with a survey to determine and map out where it presently exists. Misha offered to assist with getting the survey project underway. After completing the survey map, options for control can be discussed with LPA and implemented by LPA membership with some assistance from the State.
- 2. Phosphorous trends: LP currently has increasing levels of phosphorous which contribute to overall water quality and weed growth. Phosphorous is attached to sediment, septic seepage, manure, etc. and enters the lake though tributaries (streams) and runoff from shorelines. Most phosphorous enters lakes immediately

after heavy rains. Misha suggested that the first step would be to check the tributaries via the "LaRosa Tributary Water Quality Monitoring Program" which requires volunteers to sample each tributary 6 times a season and 2 times during rain events. The LPA would need to complete a short grant application this winter, an LPA volunteer would need to attend a one day seminar in Randolph, Vt., and then coordinate the sampling, which takes approximately one hour per sampling event. LaRosa provides information regarding the tributaries only. After completing this first step other sources of phosphorous including lake shore properties, town roads and adjacent water shed properties and farms can be evaluated. Misha suggested LPA lakeshore members address their properties first before working with the town and watershed landowners. Clean up our own properties before asking others to do so. Planting 5-10' buffer zones at lakeshore, making sure septic systems are not leaking, controlling runoff from roofs, etc. are ways in which landowners can help. See item 3 below.

- 3. "Lake Wise" program. This State program is designed for individual lakeshore property owners to access and implement actions which will reduce and/or control runoff and related sediment and phosphorous into the lake for their own properties. Misha indicated that the State could conduct a presentation to LPA landowners and members if there is interest in the Lake Wise program.
- 4. Roads and Farms; Runoff from roads and farms within our watershed also contributes to the water quality of the lake. Both State reps again recommended getting our own properties in order before approaching the Town and local farmers; in general, it's been their experience that both Town and farmers have been receptive to reducing runoff once lakeshore property owners demonstrate they have taken action on their own properties.
- 5. A "Septic Social" meeting can be held with a State presentation if LPA members and LP Watershed property owners are interested. The Shadow Lake Association held one last summer and it was well attended.

VOLUNTEERS NEEDED: As a first step, the LPA Board is looking to complete #1 above. We are looking for volunteers for a working committee. If you are interested please contact bplastridge@gmail.com You will be contacted later by Art Greenbaum as to next steps.
