Water Quality Updates from Mike Pierce

The removal of the Phragmites is set for September, 2022. Luke Hardt, the forester who will do the eradication, has asked that no-one cut the Phragmites as we need as much of the green leaves on the plants as possible. Once spring has sprung, I will set up a time for Luke to come to the lake and meet with everyone and go over his plan.

I just finished and submitted our application for the LaRosa Partnership Program. If Lake Parker is chosen for this program, we will be conducting water sampling from our tributaries. This testing allows us to engage with our local streams and tributaries firsthand and learn about water quality issues and use water testing to identify where impacts are present. Testing runs from mid-April through July. We will know by mid-February if we are accepted into this program. If so, I will be looking for a few volunteers to help with the sampling. (UPDATE: We have been selected for this program, more details to follow by email!)

I am also involved in the Vermont Invasive Patroller Program. While attending a VIP workshop in the spring I will learn how to identify and survey aquatic invasive species. During the summer I will survey for the presence of invasive plants and animals in our lake.

Once again, we are involved in the FOVLAP program (Federation of Vermont Lakes and Ponds) for 2022. There will be an annual seminar in June but as of now no information is available as far as a time or agenda for the meeting.

I have put together a small survey for everyone to fill out. Once I have this information back, I will be able to see what association members are concerned with around the lake. Fish and Wildlife News from John Wooten

2022 is looking really good for Lake Parker in the Fish and Wildlife arena!!

Thanks to the efforts of Jud Kratzer, our local State of Vermont Fish and Wildlife contact, Lake Parker is scheduled to have 900 rainbow trout stocked this Spring.

The State of Vermont has changed and simplified the fishing regulations beginning on 1 January 2022.....see the new regulations at www.vtfishandwildlife.com

This Spring, we expect to re-deploy the loon nesting raft which was built and launched last year with the assistance of the Vermont Center for Eco Studies (Eric Hanson).....this year, the loon nest raft will likely be located in the cove at the west side of the lake. Thank you to the Plastridges, the Cutlers and Day-Williams folks for

their assistance last year. As most of you know, we had a loon chick for several weeks last summer but apparently lost the "baby" to other wildlife. Hoping for better success this coming year. Update on the Wake Boat Petition from John Wooten

The "Responsible Wakes for Vermont Lakes" group has submitted its Petition to the Vermont Agency of Natural Resources (ANR) for the management of wake boat usage on all Vermont lakes and ponds. The group consists of over two dozen volunteers representing some 14 Vermont lakes and ponds.

The Petition includes approximately 140 pages and references to dozens of scientific studies. The entire Petition can be viewed on the Vermont State website at: https://dec.vermont.gov/watershed/lakes-ponds/rulemaking

The Petition is being reviewed by the ANR and others at the State level with public hearings likely during 2022 at locations around the State. It is critically important that our membership attend these hearings in large numbers to express our support for the Petition. Vigorous opposition is certain to come from the wealthy wake boat industry and its lobbyists.

At our 2021 Annual meeting, the issue of destructive wakes caused by wake boats was discussed, and those present overwhelmingly supported a petition to manage wake boat usage on Lake Parker. Last Summer and Fall, members of the LPA Board obtained over 80 signatures from lakeshore and West Glover property owners in support of wake boat management.

In December 2021, the LPA Board of Trustees voted to submit a "letter of support" for the Petition. See attached.

The Board thanks its members and neighbors for their continuing support of this important issue. More information regarding the status of this Petition will be provided as it becomes available.

Re: Support for the Petition submitted by Responsible Wakes for Vermont Lakes to amend the Vermont Use of Public Waters Rules to manage wake boat activity on Vermont lakes and ponds.

The Board of the Lake Parker Association, Inc. (LPA) writes in full support of the Responsible Wakes for Vermont Lakes Petition to the Vermont Agency of Natural Resources (ANR) to manage wake boats and their activities on Vermont lakes and ponds.

The LPA is a non profit corporation comprised of members of land owners, and West Glover residents around the Lake and within the Lake's watershed area dedicated to the preservation of Lake Parker's pristine beauty by promoting programs and educating its members regarding lake protection issues.

Artificially enhanced wakes, created by wake boats and wake-enhancing devices, cause environmental damage, degrade water quality, create safety hazards for people in or on the water, and cause physical damage to shorelines and property.

Because our focus is the preservation of Lake Parker, the LPA is particulary concerned with:

- Evidence-based adverse environmental, economic, and safety impacts of wake boats and their large enhanced wakes on all of Vermont's lakes and ponds when used within 1,000 feet of shore and at depths less than 20 feet.
- The adverse impacts large wakes from wake boats have on shoreline habitats of birds and animals, including, but not limited to loons and loon nesting.
- The adverse effects these large waves have on water quality caused by the disturbance of silt and plant growth at shorelines.

We strongly urge the ANR to act favorably on the Responsible Wakes for Vermont Lakes' petition to change the water use rules so as to manage wake boat activity in the State's waters.
