Ensure your ability to vote on issues that affect the long-term health, beauty and enjoyment of Lake Parker. Volunteers are always needed for various working groups. Taps Across America

Taps Across America was held at 3:00 PM Memorial Day on Lake Parker. We took a pontoon into the middle of the lake and raised a flag and played the taps. The National Moment of Remembrance is an annual event that asks Americans, wherever they are at 3:00 p.m. local time on Memorial Day, to pause for a duration of one minute to remember those who have died in military service to the United States. Our plan is to celebrate this every year going forward.

Water Quality Updates

The removal of the Phragmites is set for fall 2022. Luke Hardt, the forester who will do the eradication, has asked that no-one cut the Phragmites as we need as much of the green leaves on the plants as possible.

We were accepted into the LaRosa Partnership Program, conducting water sampling from our tributaries. This testing allows us to engage with our local streams and tributaries firsthand and learn about water quality issues and use water testing to identify where impacts are present.

Septic System Test Tablets

The Town of Glover has septic system testing tablets available at the Town Clerk's office for free....on a voluntary basis. The Town recommends testing but does not require it.

The green/blue tablets are to be flushed down the toilet (several flushes are recommended).

Then watch for incandescent color on the lake in front of your property; if this color appears, you have a septic system problem.

According to the Glover Health Officer, the Town is not looking to punish or chase property owners, but wishes that owners who have a problematic septic system address same, so we all have clean water in the lake for swimming, fishing etc.

Fish and Wildlife News

Thanks to the efforts of Jud Kratzer, our local State of Vermont Fish and Wildlife contact, Lake Parker received 904 rainbow trout stocked on Wednesday April 20th.

The State of Vermont has changed and simplified the fishing regulations beginning on 1 January 2022....see the new regulations at <u>www.vtfishandwildlife.com</u> The Vermont Fishing Guide & Regulations 2022 will be dropped off at every camp.

We have deployed the loon nesting raft however it seems the loons prefer to use shoreline. Signs have been posted in the water around the nesting area to protect the loons. Update on the Wake Boat Petition

The "Responsible Wakes for Vermont Lakes" group continues to work on the petition submitted to the Vermont Agency of Natural Resources (ANR) for the management of wake boat usage on all Vermont lakes and ponds.
